For the property located at 56XX 328th Avenue NE, Carnation, Washington, located within council district three, the facilities management division completed the surplus property, affordable housing and public notice requirements.

SECTION 1. Findings: The sale of 56XX 328th Avenue NE through a negotiated direct sale is authorized under K.C.C. 4.56.100.A.2. because unique circumstances make the sale in the best interests of the

SECTION 2. The executive is authorized to convey the 56XX 328th Avenue NE surplus property to Phong Robert Cha consistent with a purchase and sale agreement substantially in the form of Attachment A to this ordinance and to take all actions necessary to implement the terms of the purchase and sale agreement.
