AN ORDINANCE clarifying the transmittal of legal case records for appeal; and

amending Ordinance 13330, Section 18, as amended, and K.C.C. 4A.630.030.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Section 2 of this ordinance amends and clarifies that the legal case record, not limited to

case documents, is the topic of the transmittal for appeal and authorized fee.

SECTION 2. Ordinance 13330, Section 18, as amended, and K.C.C. 4A.630.030 are each hereby

amended to read as follows:

Transmittal of legal case ((documents)) records for appeal. The department of judicial administration is

hereby authorized to assess a fee to parties requesting transmittal of legal case ((documents)) records to the Washington state court of appeals or Washington state supreme court as part of an appeal from the decision in a King County superior court

case. The fee assessed for transmittal of the (( $\frac{\text{documents}}$ )) <u>records</u> shall be the actual cost to the department for the transmittal of the (( $\frac{\text{documents}}$ )) <u>records</u>.
