as required by the 2019-2020 Biennial Budget Ordinance, Ordinance 18835,

Section 81, Proviso P1.

WHEREAS, in the 2019-2020 Biennial Budget Ordinance, Ordinance 18835, Section 81, Proviso P1,

the King County council adopted and the executive approved, a proviso encumbering a total of \$100,000 from

planning and permitting fund and requiring a permitting already built construction program plan be transmitted

by June 29, 2019; and
