**Title:** AN ORDINANCE proposing the position of King County sheriff be returned to an appointed position

with a requirement for consideration of community stakeholder input during the selection process, and with the county executive being responsible for bargaining with the department of public safety's represented employees; amending Sections 350.20.40, 680.10 and 890 of the King County Charter and repealing Sections 645 and 898 of the King County Charter; and submitting the same to the voters of the county for their ratification or rejection at the next general election to be held in this

county occurring more than forty-five days after the enactment of this ordinance.
