WHEREAS, Federal Transit Administration ("FTA") regulations, set forth in 49 C.F.R. Part 673, require all direct and primary recipients of FTA funding to submit a Public Transportation Agency Safety Plan to the FTA regional office by December 31, 2020, and

WHEREAS, the Agency Safety Plan and subsequent updates must be signed by the Accountable Executive and approved by the agency's Board of Directors or an Equivalent Authority, under 49 C.F.R. Sec. 673.11(a)(1) (2019), and

WHEREAS, the King County Metro transit department, as a transit provider and direct recipient of FTA

funding, developed the King County Metro Agency Safety Plan in compliance with 49 CFR Part 673 and other applicable federal regulations;
