WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of local voters' pamphlets in conformity with chapter 29A.32 RCW for elections held in King County, and

WHEREAS, RCW 29A.32.280 provides for each measure from a jurisdiction that is included in a local voters' pamphlet, the legislative authority of that jurisdiction shall formally appoint a committee to prepare arguments advocating voter approval of the measure and a committee to prepare arguments advocating voter

rejection of the measure, and

WHEREAS, Ordinance 19308, adopted June 22, 2021, provides for submission to the voters at a special election to be held in conjunction with the November 2, 2021, general election, an amendment to the King County Charter to update the charter, clarify terms, and bring the charter into compliance with state law, as it pertains to referendum, initiative and charter ballot measure timelines; amending Sections 230.40, 230.50, 230.50.10, 230.60, 230.70, 230.75 and 800 of the King County Charter;
