AN ORDINANCE to provide for the carryover of expenditure authority from  
2001 to 2002; to provide additional supplemental budget authority for  
unanticipated needs; and to provide for corrections to the 2002 Adopted

Ordinance. BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
