boundaries for 2022; amending Ordinance 16803, Section 1, as amended, and

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 16803, Section 1, as amended, and K.C.C. 1.12.050 is hereby

amended to read as follows:

A. The district court west electoral district shall be all the area described in subsection B. of this section. The be

B. West electoral district: all of the area within the boundary of the city of Seattle which

includes to the centerline of the waters of Puget Sound and the centerline of Lake Washington.

- C. The boundaries of the other electoral districts shall consist of the election precincts in Attachments A through D to ((Ordinance 18886)) this ordinance, as listed in this subsection, which shall be retained officially on file in the department of elections, with copies maintained by the clerk of the council and the presiding judge of district court.
