BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. From various funds there is hereby approved and adopted \$4,478,000 to various current expense and non-current expense agencies, in addition to funding the Risk Abatement IV/OMB IT/Class comp fund to implement the Information Technology Class/Comp agreement.
