BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memorandum of agreement negotiated between King County and International Brotherhood of Teamsters Local 117 (Joint Crafts Council, Construction Crafts - Appendix N) representing

security screeners in the department of executive services and attached hereto is hereby approved and adopted by this reference made a part hereof. It modifies the existing collective bargaining agreement between the parties which expires December 31, 2005.
