BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memorandum of agreement regarding wage re-opener negotiated between King County and Technical Employees Association, representing employees in the department of natural resources and parks, and attached hereto is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from July 1, 2002, through and including June 30, 2005.
