A MOTION approving the first and second quarter financial reports for the printing and graphic arts fund as meeting the requirements of a budget proviso presented in Section 14 of Ordinance 15333.

WHEREAS, the 2006 Budget Ordinance, Ordinance 15333, Section 14, declared that \$150,000 of the office and management and budget 2006 appropriation shall be expended or encumbered only in increments of \$50,000 after council approval by motion of each of the three quarterly reports on actual revenues and expenditures in the printing the graphic arts funds, and

WHEREAS, the quarterly reports shall be submitted using a format developed by the office of management and budget in collaboration with staff of the council and the information and telecommunications services ("ITS") division, and

WHEREAS, the office of management and budget in collaboration with staff of the council and the ITS division has developed a quarterly reporting format and has produced the reports on the actual expenditures and revenues of the printing and graphic arts fund for the first and second quarters of 2006;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The report on actual expenditures and revenues in the printing and graphic arts fund for the first and second quarters of 2006, Attachments A, B and C to this motion, is hereby approved.
