The fourth Wednesday of each month at 3:00 p.m.

The second and fourth Tuesdays of each month at 1:30 p.m.

Growth management and natural resources committee:

The ((first,)) second, third and fourth Tuesdays of each month at 9:30 a.m., unless the

committee of the whole is meeting at that time because the preceding Monday was a state or

county holiday.

((Labor, operations and technology committee:

The second and fourth Tuesday of each month at 1:30 p.m.))

Law, justice and human services committee:

First and third Thursdays of each month at 9:30 a.m.

Operating budget, fiscal management and mental health committee:

The second and fourth Wednesdays of each month at 9:30 a.m.

The second and fourth Wednesdays of each month at 1:30 p.m.

Regional policy committee:

The ((first)) second Wednesday of each month at 3:00 p.m.

Regional transit committee:

The third Wednesday of each month at 3:00 p.m.

The ((second)) first Wednesday of each month at 3:00 p.m.
