AN ORDINANCE relating to taxicab and for-hire vehicles, increasing fees;

amending Ordinance 13334, Section 2, as amended, and K.C.C. 6.64.025.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Section 2 of this ordinance proposes changes to existing taxicab and for-hire vehicle fees

within the licensing section of the records, elections and licensing services division.

SECTION 2. Ordinance 13334, Section 2, as amended, and K.C.C. 6.64.025 are each hereby amended
