AN ORDINANCE relating to the annexation of approximately 120 acres of land into the Sammamish Plateau water and sewer district, known as the Siler Ridge Water Annexation, for the purpose of water service.

### STATEMENT OF FACTS:

1. A notice of intention proposing the annexation of approximately 120 acres of land into the Sammamish Plateau water and sewer district, known as the Siler Ridge Water Annexation, for the purpose of water service was filed with the county council on October 6, 2022.
2. The Sammamish Plateau water and sewer district has approved the proposed transfer in Resolution No. 5135, passed on September 12, 2022.
3. The Sammamish Plateau water and sewer district filed a determination of nonsignificance on the proposed transfer dated June 21, 2022.

4. The utilities technical review committee reviewed the Sammamish Plateau water and sewer district 2018 water comprehensive plan and found that plan met the criteria for approval. The county approved the most recent plan for the Sammamish Plateau water and sewer district in 2020, as part of Ordinance 19069.

5. The county council held the legally required public hearing and has considered the criteria in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of approximately 120 acres of land into the Sammamish Plateau water and sewer district for the purpose of providing water service described in Attachment A to this ordinance is approved. Approval of this proposed annexation is consistent with RCW 57.02.040.

SECTION 2. The Sammamish Plateau water and sewer district is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.
