BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and the

Washington State Council of County and City Employees, Council 2, Local 21DC representing employees in

the King County District Court, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of the agreement shall be effective from January 1, 2021, through and including December 31, 2024.
