AN ORDINANCE revising the corporate boundary of the city of North Bend to include all of SE 136th Street right-of-way, as provided for in RCW 35.21.790.

## STATEMENT OF FACTS

- 1. The city is currently designing and constructing a sewer system to serve the Tanner and Truck Town areas of the city.
- 2. A portion of the sewer main is planned to be located in the right-of-way of SE 136th Street.
- 3. The proposed location of the sewer main is the most advantageous for routing and for future service to the area.
- 4. It is in the city and the county's best interests to have this right-of-way under the city's jurisdiction so the city may accomplish the construction of the sewer main in the roadway and

other necessary road repairs under city codes and standards.

- 5. The city's corporate boundary currently extends along the north margin of SE 136th Street from 436th Avenue SE eastward to the terminus of SE 136th Street.
- 6. The city approved Ordinance number 1364 to revise its corporate boundary at SE 136th Street to include all of the road right-of-way within the corporate limits of the city.
- 7. RCW 35.21.790 authorizes "The governing bodies of a county and any city or town located therein may by agreement revise any part of the corporate boundary of the city or town which coincides with the centerline, edge, or any portion of a public street, road or highway right-of-way by substituting therefor a right-of-way line of the same public street, road or highway so as fully to include or fully to exclude that segment of the public street, road or highway from the corporate limits of the city or town."
- 8. Revision of the corporate boundary of a city is effective upon approval by the city council and the county legislative authority as provided for in RCW 35.21.790.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The revision of the corporate boundary of the city of North Bend to include the segment of SE 136th Street right-of-way, legally described as set forth in Attachment A to this ordinance, is hereby approved.
