AN ORDINANCE approving and adopting the collective bargaining agreement negotiated by and between King County and International Federation of Professional & Technical Engineers, Local 17 representing employees in the departments of development and environmental services, executive services,

natural resources and parks and transportation; and establishing the effective date of said agreement.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and International Federation of Professional & Technical Engineers, Local 17 (Departments: Development and Environmental Services, Executive Services, Natural Resources and Parks, Transportation) representing employees in the departments of development and environmental services, executive services, natural resources and parks and transportation, and attached hereto is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from May 1, 2010, through and including April 30, 2011.
