BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. A. Section 2 of this ordinance states the department of judicial administration will assess

fees for actual costs for transmittal of legal case documents.

B. This fee is assessed pursuant to K.C.C. 4.71.060.

SECTION 2. Ordinances 13330, Section 18, and K.C.C. 4.71.060 are each hereby amended to read as

follows:

Fee - transmittal of legal case documents for appeal. The department of judicial administration is

hereby authorized to assess a fee to parties requesting transmittal of legal case documents to the Washington

State Court of Appeals or Washington State Supreme Court as part of an appeal from the decision in a King

County superior court case. The fee assessed for transmittal of the documents shall be ((twenty-five dollars per

transmittal to cover all costs of transmittal of the documents)) the actual cost to the department for the
