AN ORDINANCE relating to the application fee for the processing of current use permits; amending Ordinance 13332, Section 38, as amended, and K.C.C. 27.10.230, adding a new section to K.C.C. chapter 20.36 and recodifying K.C.C.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Ordinance 13332, Section 38 as amended and K.C.C. 27.10.230 are each hereby amended to read as follows:

A fixed Fee for the processing of current use permits shall be charged as follows:

A. Farm and agricultural land classification	\$181.00
B. Open Space and timber <u>land</u> <del>((less than twenty acres))</del>	<del>\$((241.00))</del>
	<u>480.00</u>
<del>((Open space and timber greater than twenty acres</del>	<del>\$483.00))</del>

SECTION 2. Ordinance 13332, Section 38, as amended, and K.C.C. 27.10.230 are each hereby recodified as a new section in K.C.C. chapter 20.36.
