## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and two memoranda of agreement negotiated by and between King County and Amalgamated Transit Union, Local 587 (Transit - Departments: Transportation, Executive Services (Finance and Business Operations Division)) representing employees in the departments of transportation and executive services and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall be effective from November 1, 2010, through and including October 31, 2013.
