AN ORDINANCE authorizing the county executive to execute an amended interlocal agreement between King County and the city of Seattle regarding Public Health - Seattle & King County.

STATEMENT OF FACTS:

1. King County and the city of Seattle desire to continue the operation of Public Health - Seattle & King County to provide opportunities for enhanced public health services to city of Seattle residents and neighborhoods.
2. The county has the expertise and statutory responsibility for the delivery of public health

services throughout the county, including in the city.

3. Participation in the agreement is to the benefit of the residents of the county.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. The county executive is hereby authorized to execute, substantially in the form of Attachment A to this ordinance, an interlocal agreement between King County and the city of Seattle.
