BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The seven memoranda of agreement negotiated by and between King County and certain unions representing King County employees addressing the 2011 budget crisis and detailing cost of living increases for the years 2011 through 2014 and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall take effect on January 1, 2011.
