STATEMENT OF FACTS:

1. Issaquah School District No. 411 desires to provide school resource officer services in

schools within its jurisdiction. For the 2011-2012 school year, the school district has requested

\$55,000 in part-time school resource officer services to be provided.

2. The county has the ability to provide these school resource officer services.

3. Participation in the agreement is to the benefit of the citizens of King County.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

<u>SECTION 1.</u> The county executive is hereby authorized to execute a contract

agreement with Issaquah School District No. 411, in substantially the form of Attachment A to this ordinance.
