## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memorandum of agreement negotiated by and between King County and a coalition

of six unions representing employees in administrative support classifications in multiple departments

throughout King County, attached hereto, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective through and including December 31, 2013.
