## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and memorandum of agreement negotiated by and between King County and Public Safety Employees Union (Department of Adult and Juvenile Detention Management) representing employees in the department of adult and juvenile detention and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of the collective bargaining agreement shall be effective from January 1, 2012, through and including December 31, 2014. Terms and conditions of the memorandum of agreement shall be effective from January 1, 2011, through and including December 31, 2014.
